Who We Are: a non-profit law firm and employment justice organization which empowers low-income families, workers, and communities to achieve fair treatment in the workplace, in the justice system, and in our society – regardless of immigration status.

Our Work:

- Provides legal representation that enables low-wage working men and women to recover millions in unpaid wages and to combat sexual harassment and other basic injustices they encounter in their work.
- Achieves systemic reforms that strengthen employment rights and expand access to the justice system for all working people.
- Empowers immigrant families and Dreamers with protections from unjust deportation and work place exploitation.
- Hosts a law student clinic with the UT Law School where law students learn the arts of employment litigation and public interest law practice.
- Trains the next generation of employment rights advocates – workers, students, lawyers, and community members.
